The international conference «Cultural Third Spaces ? Towards New Means of Cooperation between Africa and France ?» will take place on May 17 at Friche la Belle de Mai in Marseille. It is organized by Friche la Belle de Mai and by Campus AFD (Agence Française de Développement), in their ongoing commitment to supporting the cultural third spaces that create learning ecosystems to encourage sustainable transitions.

This conference is in line with the dynamic behind the Africa-France Summit and Saison Africa 2020. It aims to pool existing thought processes and dynamics related to cultural third spaces, and to pave the way for the formation of a network.

This conference will bring together the heads of cultural hubs from several countries in Africa (Mozambique, Senegal, Mali, South Africa, DRC, Kenya, Rwanda, Morocco, Tunisia) as well as France, and will include on-site visits and interactions with the cultural third spaces of Marseille, including the long-standing exemplar Friche la Belle de Mai. Discussions and round tables will be enriched by the presence of two philosophers: **Achille Mbembe** and **Gabrielle Halpern**.

In contrast to the formality of traditional cultural establishments, third places allow the creation and dissemination of culture to take place in spaces that are open to the public, multi-use, and ever-changing (Besson, 2018). These venues are primed to kindle both formal and informal exchanges among a diverse group of individuals: cultural actors, students, gardeners, researchers, manufacturers, craftspeople, entrepreneurs, urbanists, artists, and even local residents, children, amateur creators, and other users.

The objective of this conference is to present and discuss cultural third places in Africa in terms of the following:

• Venues and models of governance and economic exchange within cultural third spaces.

• Transformations within the sphere of cultural and artistic action. Cultural third places in Africa are at the forefront of important questions about the role of culture and the arts in society. They are rewriting the narrative about the status of artists and artworks, the position of audiences and viewers, the function of mediation and cultural action, and the role of cultural facilities and heritage, among other aspects.

• Ramifications in the fields of educational action and learning systems, considering the major challenges around education in Africa.

• Impacts on the issues of transitions toward sustainability in Africa—including drought, water access, climate, agriculture, food security, gender equality, social ties, the (re)construction or reappropriation of cultural identity—and local and international public action.

Cultural third places are alternative, hybrid spaces that raise important issues around artistic creation, redefining governance, how institutions are generated, and economic models and managerial practices for cultural spaces. They aim to reinvent the relationship between art and society by experimenting with new forms of art and culture. What are the main characteristics of these innovative cultural spaces? How are they different from traditional cultural institutions, "New Art Territories," cultural intermediary spaces, and other types of cultural center? Should we view these new cultural spaces as nothing more than the latest trend—so much smoke and mirrors? Or do they represent the emergence of a model paving the way for a new age of cultural policies and institutions?

Can they be venues for redefining relations and cooperation between France and Africa? Will they become new meeting-places for important actors in African and French civil society? How do they resonate with contemporary decolonial and postcolonial studies?
